**Notice for Election of Office Bearers and
Executive Council Members of the
Association of Domestic Tour Operators of India – 2018**

Notice is hereby given to all members of Association of Domestic Tour Operators of India for the conduct of the election to the Office Bearers and Executive Council Members of the Association of Domestic Tour Operators of India, as per the following schedule and in accordance with the Constitution of the Association of Domestic Tour Operators of India and in accordance with existing Acts/Laws/Rules/Regulations (copy enclosed as Annexure-I):-

2. (a) As per Articles 7 and 11 of the Constitution of the Association of Domestic Tour Operators of India (hereinafter referred to as 'ADTOI'), the Executive Council of ADTOI, shall consist of 5 (Five) Office Bearers and 8(Eight) Executive Council Members elected by the General Council of ADTOI.

(b) The 13 (Thirteen) Officer Bearers and Executive Council Members shall be as follows:-

(i)	President	1 (one)
(ii)	Vice-President	1 (one)
(iii)	General Secretary	1 (one)
(iv)	Treasurer	1 (one)
(v)	Joint Secretary	1 (one)
(vi)	Executive Council Members	8 (Eight)

3. Office Bearers and members of Executive Council of ADTOI shall be elected by secret ballot in person/postal ballot. The facility of secret ballot in person shall be provided for those members who reside in Delhi/NCR. The facility of postal ballot shall be provided for those members who reside outside Delhi/NCR.

4. As per Article 12 (Election Process), no proxy voting shall be allowed in this election of ADTOI. The second representative of the active member to be allowed to cast their vote on the elector's behalf, for both in secret ballot, in person/postal ballot.

5. Electors who reside outside Delhi/NCR are entitled to vote only by post. Their names are registered in the last part of the electoral college of the ADTOI and the returning officer shall send postal ballot papers to them without any application or request from them in this behalf. The postal ballot paper, after marking by the elector or second representative, should reach the returning officer at two days, before the date of poll. The postal ballot papers for all electors who reside outside Delhi/NCR shall be sent back to returning officer by post (either by Speed Post/Courier) or to be delivered to returning officer personally at two days before the date of poll. The returning officer shall not responsible for any delay of postal ballot papers. The returning officer will not count all postal ballot papers, which was received by the returning officer after last date mentioned in the



schedule for receiving the postal ballot papers. **As a special case a written option can be exercised by the member who resides outside Delhi/NCR to cast his vote in person as of by the member who resides in Delhi/NCR. The option to vote in person should reach the Returning Officer on or before 5 pm on 26th July, 2018. The postal ballot paper may not be sent through post to those who opted to vote in person. The option once exercised by member shall be treated as final whereafter no change be allowed.**

6. While issuing the postal ballot papers, the returning officer shall record on the counterfoil of the ballot paper, the electoral college number of the elector to whom it has been issued. If a postal ballot paper is returned undelivered to the returning officer for any reason, the returning officer shall not re-issue the said postal ballot papers to the elector personally on a request being made by him. No envelope of postal ballot papers by the returning officer after the expiry of the time fixed in that behalf shall be opened and no vote contained in any such cover shall be counted. The other covers shall be opened one after another and as each cover is opened, the returning officer shall first scrutinize the declaration of attestation in Form No.6 contained therein. If the said declaration is not found, or has not been duly signed and attested, or is otherwise substantially defective, that cover shall not be opened, and after making an appropriate endorsement thereon, the returning officer shall reject the ballot paper therein contained. Each cover so endorsed and the declaration received with it shall be replaced in the cover in Form 6 and all such covers in Form 6 shall be kept in a separate packet which shall be sealed and on which shall be recorded. The returning officer shall then place all the declarations in Form 6 which he has found to be in order in a separate packet which shall be sealed before any cover. A vote recorded on a postal ballot paper shall be rejected if the mark indicating the vote is placed on the ballot paper in such manner as to make it doubtful to which candidate the vote has been given. A vote recorded on a postal ballot paper shall not be rejected merely on the ground

that the mark indicating the vote is indistinct or made more than once, if the intention that the vote shall be for a particular candidate clearly appears from the way the paper is marked. The Returning officer shall count all the valid votes given by postal ballot in favour of each candidates record the total thereof in the result sheet and announce the same at the time of declaration of result.

7. As per Article 12(m) all members who have completed two years with the Association should only be allowed to contest the election.

8. As per Article 10 of the Constitution of ADTOI of the Constitution, only active members who have completed three months from the date of grant of membership shall have right to cast his/her vote. (three months would be counted as on date of commencement of nomination process i.e. 16.07.2018) No member shall be entitled to vote or be counted as a member whose subscription at the time shall have been in arrears for a period exceeding three months (as per Rule 15 of the Registration of Societies Act, 1860).

9. As per Article 11(b) of the Constitution of ADTOI, a member of the Executive Council, who has completed one term (two years) in the Executive Council, shall have the right to contest as office bearers post.

10. As per Article 11(e) of the Constitution of ADTOI, all the contesting candidate are required to disclose and enclose with nomination papers the preceding year turnover duly signed and certified by the Chartered Accountant and also enclose the profile of his/her Enterprise.

11. As per Article 11(i) of the Constitution of ADTOI, active member who have completed two years in the Association shall have the right to contest the election.

12. As per Article 11(j) of the Constitution of ADTOI, any office bearer, who is holding any post in TAAL, TAFI, IATO, IAAI, ITTAI, etc., shall not eligible to contest this election.

13. The SCHEDULE of the above mentioned election is as follows:-

6.	Publication of the final list of contesting candidates in Form-5	25 th July, 2018 (Wednesday) at 6.00 p.m.
7.	Date of issuing postal ballot papers to electors with Form-6 (Declaration by elector of attestation of signature).	27 th July, 2018 (Friday) and 28 th July 2018, (Saturday)

14. The nomination of a candidate for election as office bearers or a member of executive council shall be proposed by one of the representatives of member whose name is included in the Electoral College list and also subscribed by 1 (one) such representative as seconder.

15. Each candidate shall be entitled to be nominated by only one nomination paper.

16. Each nomination paper shall be delivered personally to the Returning Officer, in person by the candidate himself/herself as per the schedule mentioned above. This facility for delivering of nomination by the candidate himself/herself in person shall be for those members who resides in Delhi/NCR and delivering of nominations by post shall be available for those who resides outside Delhi/NCR. The nominations by post shall be delivered by post as per schedule mentioned above i.e. nomination should reach the Returning Officer on or before 5 pm of 21st July 2018. The nomination papers received by post by the R.O. is subject to acceptance after due verification of signatures of candidate, proposer and seconder by the staff of ADTOI Secretariat. Any nomination paper received later than 05.00 p.m., on the day fixed, shall be summarily rejected.

17. No person shall be eligible to nominate more than one candidate for the same post, either as proposer or seconder; and, if he so does, his/her signature on the nomination paper delivered second in point of time to the returning officer shall be deemed to be inoperative.

18. No person shall be permitted to withdraw his/her name as proposer/seconder, once the nomination paper subscribed by him/her has been delivered to returning officer.

19. At the scrutiny of nominations, each candidate or one of his/her authorized representative shall have the right to be present and raise any objection in relation

to nominations of the candidate for the post for which he/she has filed his/her nomination.

20. On the day of scrutiny, the Returning Officer in his Office shall scrutinize each nomination paper, one by one, received by him, and determine its validity or otherwise.

21. At the scrutiny of nominations, each candidate or one of his/her authorized representative shall have the right to be present and raise any objection in relation to nomination of a candidate for the post for which he/she has filed his/her nomination. As soon as may be after the scrutiny of all nomination papers has been completed by him, the Returning Officer shall prepare a list of validly nominated candidates in **Form 5**. Contesting Candidates can take a copy from the Returning Officer.

22. Each candidate whose nomination has been found valid on scrutiny, shall be entitled to withdraw his/her candidature, from 24th July, 2018 (Tuesday) to 25th July, 2018 (Wednesday) between 2.30 p.m. and 5.00 p.m.

23. Notice of withdrawal of candidature shall be submitted in **Form 4**, either by the candidate himself/herself or by a person duly authorized by him/her in writing.

24. Notice of withdrawal of candidature shall be final and shall not be allowed to be cancelled.

25. The Returning Officer shall accept the notice of withdrawal if he is satisfied as to the genuineness of the notice.

26. As soon as may be after the scrutiny of nominations, the Returning Officer shall prepare the final list of contesting candidates in **Form-5**, display a copy of the said list in the office of the Returning Officer. And also furnish a copy of the same to each of the candidates/their authorized representatives, if they so demand.

27. The names of the contesting candidates in **Form 5** shall be arranged, for each post, in alphabetical order according to English alphabets.

28. Where the number of contesting candidates for any post, in **Form 5** is equal to the number of posts to be filled, all such contesting candidates shall be deemed to be duly elected unopposed to those posts, and it shall not be necessary to take a poll for election to such post.

29. Where the number of contesting candidates for any post, in **Form 5** is more than the number of posts to be filled, a poll shall be taken by secret ballot and postal ballot papers, for those posts remaining unfilled.

30. The ballot papers for these posts remaining unfilled shall be in **Form 7** to **Form 13** to be made individually for each post.

31. The names of contesting candidates on the ballot papers shall appear in the same order as in **Form 5**.

32. Each contesting candidate can nominate one person, (If he/ she so desires), only from amongst the list of electoral college, to be present at the Poll (Polling station).

33. At the poll, each member or second authorized representative, whose names are in the electoral college, shall be entitled to –

- (i) cast one vote for each of the posts remaining unfilled, where only one such seat is to be filled;
- (ii) cast as many votes as are the no. of seats to be filled for any post, where more than one seat is to be filled.

34. In case any voter casts his/her vote for more than the candidate, or candidates to be elected from any post, his/her vote for that post shall be invalid.

35. Each voter shall be required, before he is supplied with a Ballot paper, to give his/her signature on the authenticated copy of the Electoral College used by the Returning Officer for taking the poll.

36. The voter shall record his/her vote on the ballot paper in secrecy in a voting compartment specially provided for the purpose at the polling station.

37. The voter shall record his/her vote on the ballot paper by placing a tick mark (✓) against the name of the candidate of his/her choice, and any other mark, like (x) etc. or word, placed on the ballot paper by him/her shall render the ballot paper liable to rejection.

38. At the time of poll, the tick mark (✓) to indicate the vote shall be placed by the voter only by means of article specifically provided for the purpose by the Returning Officer, and a ballot paper marked otherwise by means of any pen, ball point pen, etc. by the voter shall render the ballot paper liable to rejection. In the case of postal ballot papers, the electors are entitled to tick mark (✓) on the postal ballot papers by means of any ball point pen (Blue Colour) only. The electors, who tick mark (✓) by means of any other coloured/black pen on the postal ballot papers, shall render the ballot paper liable to rejection.

39. The ballot paper marked by a voter, in person, shall be deposited by him/her in a ballot box specially prepared and sealed by the Returning Officer and placed at such a conspicuous place in the polling station that it shall be constantly visible to all present in the polling station.

40. The Returning Officer shall close the poll at the appointed hour; however, all those voters who are present at the polling station at the appointed closing hour shall be entitled to vote even if the poll proceedings have to be continued for some more time.

41. After all the voters, referred to above, have voted, the Returning Officer shall close the ballot box and shall not permit thereafter any person to vote.

42. The Returning Officer shall take up the counting of votes as soon as may be after the polling is closed.

43. Each contesting candidate can nominate one authorized representative and he/she shall be entitled to be present at the place of counting of votes.

44. The Returning Officer shall take up the counting of votes, post-wise.

45. Each ballot paper on which a vote has been recorded as mentioned above, shall be treated as one vote for the candidate for whom it has been validly marked; and if any ballot paper has been marked in violation of any of the aforesaid provisions shall be rejected by the Returning Officer.

46. The votes validly cast for each of the contesting candidates shall be counted post-wise, and recorded in the descending order of the votes so cast for each candidate in **Form 14**.

47. The Returning Officer shall thereafter ascertain the result of counting and the candidates who have secured the maximum no. of votes in the said descending order, post-wise, equal to the no. of seats to be filled for each post, shall be deemed to have been duly elected to those posts.

48. The names of contesting candidates who shall be deemed to have been elected at the election, as per mentioned above, shall be declared as having been duly elected to their respective posts by the Returning Officer in the **Form 15**.

50. The venue for all activities mentioned in Item Nos. 1 to 8 in the Schedule above, shall be the Office of the Returning Officer **No.403, 4th Floor, Padma Tower-II, Rajendra Place, New Delhi – 110008**.

51. This may kindly be noted that all disputes are subject to the jurisdiction of the courts of Delhi only.





 - (4) In case, votes are cast for more than 8 (eight) candidates, all votes shall be liable to rejection.
 - (5) In the case of postal ballot, the electors are entitled to tick mark (√) on the postal ballot papers by means of any ball point pen (Blue Colour) only. The elector who ticks mark (√) by means of any other coloured/black pen on the postal ballot paper, shall render the ballot paper liable to rejection.
